THE FIGHT IS NOT OVER!

A Message from Erik Geizer, CEO of the Arc of NY State

The final NYS budget was released on May 1, and we were all stunned and disappointed by the inadequate investment in our service system. This budget only reaffirmed that our fight is far from over.

We cannot let up on our advocacy – we need your voice! We will grow louder. We will grow fiercer. We will not let New Yorkers with I/DD be forgotten.

FINAL BUDGET RELEASED

In the final budget, nonprofit providers of supports and services for New Yorkers with intellectual and developmental disabilities will receive a mere 4% cost of living increase.

This minimal increase covers less than half the increase in inflation over the past year. It does nothing to reverse our escalating workforce crisis. Most importantly, it does not address the erosion of care and supports for New Yorkers with I/DD.

A Message from Erik Geizer (Continued)

Paired with the reality of inflation, a 4% COLA has become essentially a 4.5% cut.

New Yorkers with I/DD needed meaningful investment to sustain quality supports and care. Our staff needed meaningful investment to align their compensation with their skill and dedication. We called for an 8.5% COLA and a Direct Support Wage Enhancement to meet those needs. The legislature included an 8.5% COLA and no DSWE in their budgets. We advocated fiercely for that compromise to be realized, but the end result is entirely inadequate.

ADVOCACY PUSH FOR THE DSWE

Although we did not achieve all of our budget objectives during this fiscal year, we continue to advocate for The Direct Support Wage Enhancement (DSWE) as a stand-alone piece of legislation (S4127/A5268) sponsored by Senator Mannion and Assemblymember Seawright.

With the DSWE, provider agencies would receive a permanent annual funding allocation of \$4,000 per eligible employee to be used for purposes of enhancing the hourly rate of pay for all staff that have direct care/support responsibilities for individuals with I/DD. This proposed increase of \$4,000 equates to approximately \$2.19 an-hour for a full-time employee – a necessary amount that will allow DSPs and employees the ability to provide for their families and keep the I/DD sector competitive.


