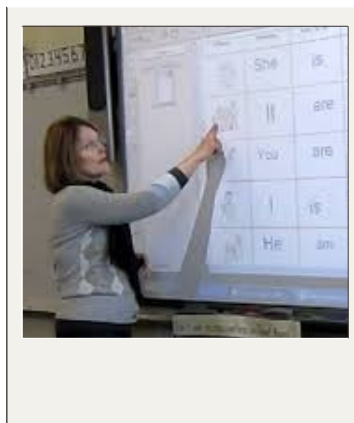

We MATTER!

SYRACUSE--A "We Matter" rally, organized by the Arc of Onondaga and Access CNY and joined by representatives from Oswego Industries, the Arc of Oswego County, the Arc of Madison Cortland, and the Arc of Oneida-Lewis, brought together nearly 300 people at the state fairgrounds. The event's primary goal was to advocate for increased funding in the state budget to support staff and services for individuals with disabilities.

The participants gathered to call on state lawmakers and then-Governor Kathy Hochul to allocate just over \$250 million in the budget. This funding would have covered a 3.2 percent cost-of-living adjustment, a \$4,000 wage retention, and enhancement for direct support professionals. These professionals play a crucial role in assisting individuals with intellectual and developmental disabilities.

The rally provided a platform for current and former direct support professionals, caregivers, and individuals with disabilities. Additionally, Assemblyman Al Stirpe (D-Cicero), Julie Fleck representing Senator John Mannion (D-District 50), Matt Jones representing Assemblywoman Pamela Hunter (D-Syracuse), and Nodesia Hernandez representing Senator Rachel May's office (D-District 48) addressed the attendees.

The involvement of these representatives and officials reflected the collaborative effort to highlight the importance of increased financial support for the disability services sector. The rally served as a powerful initiative to raise awareness about the needs of this community and to urge policymakers to prioritize funding that ensured the well-being of individuals with disabilities and the professionals who supported them.

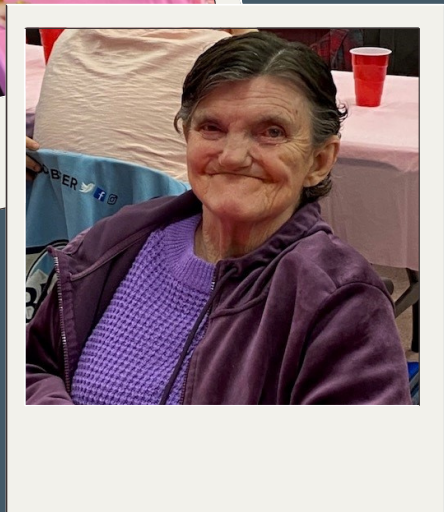

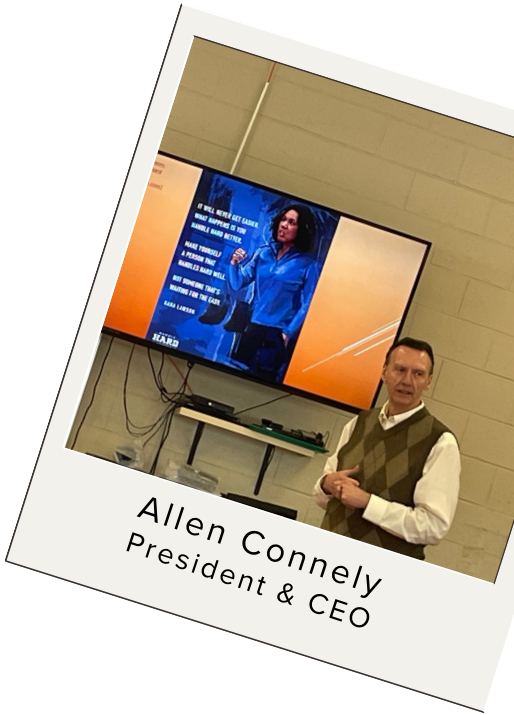

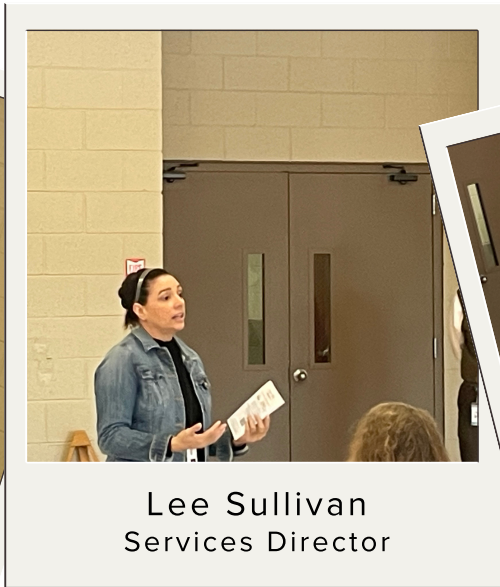
